<p><b>Plain English explanation</b>          AccuRx is an online service allowing patients to contact the practice with both Medical and Administrative queries. We use a Triage product from them to support queries we receive.</p>

<p><b>3) Purpose</b> of the processing</p>	<p>The information that is shared to support patient care.</p>
<p><b>4) Lawful basis</b> for processing</p>	<p>The processing of personal data in support of direct care elsewhere is supported under the following Article 6 and 9 conditions of the UK GDPR: Article 6(1)(d) ‘processing is necessary to protect the vital interests of the data subject or of another natural person’. Article 6(1)(e) ‘...necessary for the performance of a task carried out in the public interest or in the exercise of official authority...’. Article 9(2)(c) ‘processing is necessary to protect the vital interests of the data subject or of another natural person where the data subject is physically or legally incapable of giving consent’. Article 9(2)(h) ‘necessary for the purposes of preventative or occupational medicine for the assessment of the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or the management of health or social care systems and services...’. We will also recognise your rights established under UK case law collectively known as the “Common Law Duty of Confidentiality”*.</p>
<p><b>5) Recipient or categories of recipients</b> of the shared data</p>	<p>The data will be shared with Accrux to support the management of administrative queries.</p>
<p><b>6) Rights to object</b></p>	<p>You have the right to object to some or all of the information being shared. Please contact our Data Protection Officer.</p>
<p><b>7) Right to access and correct</b></p>	<p>You have the right to access the data that is being shared and have any inaccuracies corrected. There is no right to have accurate medical records deleted except when ordered by a court of Law.</p>
<p><b>8) Retention period</b></p>	<p>The data will be retained for active use during the processing and thereafter according to NHS Policies and the law.</p>
